- 专为人声设计适合的频率响应，提高了人声表现且可有效控制近讲效应







■ 使用说明

1. 麦克风与线材连接时，将线材的卡侬头对准麦克风尾部的三针插入，直至扣键定位。
2. 将麦克风线材的另一端与调音台、功放、声卡等音频设备连接即可使用。




3. 麦克风可手持，也可以安装到支架上使用。安装支架使用时，先将配套的麦克风夹子安装到带有3/8”或5/8”标准螺纹接口的麦克风支架上，再将麦克风安装到夹子上，如图所示：



4.建议使用时，应先将音频设备（声卡、调音台等）音量调小，再将音量从小到大慢慢调节至合适，以免声压过大对扬声器造成冲击；尽可能地拉开麦克风与扬声器的距离，避免麦克风和扬声器相对，以免影响麦克风音质及有效控制回馈啸叫。

5.超心型麦克风的扬声器推荐位置：

超心型麦克风在后方位120°位置时，具有很强的声音抑制特性，属于收音较弱的区域，调节麦克风位置，让监听音箱等不必要的音源位于这些角度，而不是麦克风的正后

6.麦克风与连接线分离时，可握住插头并按压卡侬扣键，将线材拔出即可。

- Tailored frequency response for vocals, which improves vocal performance and reduces proximity effect




■ Operation Instructions

- 1.To connect the mic with XLR cable, align the XLR connector with the 3-pin connector on mic, then insert fully until the XLR lock button locks in place.
- 2.Connect the other end of the XLR cable with audio device, e.g., mixer, power amplifier, audio interface.




- 3.Hold the mic by hand, or install it on a stand. For stand installation, first fix the mic clamp onto the 3/8" or 5/8" standard-threaded connector on the stand, then secure the mic onto the clamp as shown below:



4. Please turn the volume to the minimum on the audio device (e.g., audio interface, mixer) before switching on the phantom power. Then gradually increase the volume to an appropriate level. This helps to prevent the speakers from being damaged by high sound pressure. Keep a proper distance between the mic and the speakers to avoid feedback howling and ensure audio quality.

5. Recommended speaker positions for supercardioid mics:

Sound rejection is at its strongest when positioned at about 120° behind a supercardioid mic. Therefore, adjust the position of the mic so that unwanted sound sources such as monitor speakers are located at these angles, rather than directly behind the mic.

6. To disconnect the mic from XLR cable, press down the XLR lock button and unplug the cable.

■ Safety Instructions
