




■ 防护等级 (IPX8) 说明

■ 使用说明

一、开机/关机

开机:长按电源键3秒开机,伴随提示音,指示灯红蓝灯交替闪烁。

关机: 开机状态下, 长按电源键3秒关机, 伴随提示音, 指示灯红灯闪1次后熄灭

二、无线连接

首次使用本机时,需要与手机或无线播放设备配对连接,步骤如下;


- 1. 长按耳机电源键3秒开机, 耳机自动进入搜索配对状态, 指示灯红蓝灯交替闪烁。
- 2. 打开智能设备"设置"菜单,找到无线连接列表,搜索"TAKSTAR LR150W"进行连接、连接成功后伴随提示音。

注:

- 1. 已配对设备, 耳机开机后, 将自动回连最后一次成功连接过的智能设备, 回连时间3分钟。
- 2. 耳机超过回连时间3分钟后, 将自动关机。

四、低电提示与充电

- 1. 耳机使用过程中, 低电时会发出低电提示音, 请及时为耳机充电。
- 2. 充电状态下, 指示灯长亮红灯; 充满后, 指示灯长亮蓝灯。

注意:请确保磁吸充电时正负极正确对应,相互吸附可正常充电,相互排斥则无法充电,切勿强行让磁吸贴合接触以免造成电路短路。

注: 充电必须使用输出电压5V适配器, 勿使用大于5V适配器进行充电, 可能会造成损坏。



五、音乐文件下载储存

- 1. 使用标配数据线, 带磁吸功能充电头一端与耳机触点紧密贴合, 另一端连接 到电脑的USB接口。
- 2. 电脑识别成功后自动弹出可移动磁盘窗口, 打开音乐软件下载歌曲, 将音乐 文件 (譬如MP3格式) 拷贝至耳机的储存盘中
- 操作完成后,鼠标右击桌面右下角安全弹出图标,左键单击"弹出可移动磁盘", 等待电脑提示安全移除后,拔出数据线。

■ 安全使用说明

为了您有一个安全与舒适的体验,请仔细阅读并遵守以下事项:

- 1. 为了避免听力受损,请务必在连接耳机前将播放设备音量调小。在将耳机佩 戴入耳内/耳上之后,再逐步调大至您聆听舒适的音量。噪音是以分贝(dB)为 计量单位的,外界任何85分贝及以上的噪音都会导致听力逐渐受损。
- 清注意您的使用习惯。音量和时间对听力损失的影响成正比的关系,音量越大,您的聆听时间越短;音量越舒适,您聆听的时间越长。长时间使用较高的音量会对您的听力造成损伤。



■ Protection Rating (IPX8)

This product is waterproof and sweat-resistant, tested under controlled lab conditions to meet GB/T4208-2017 standards for IPX8 (equivalent to IEC IPX8: protection against continuous immersion in water at a pressure of 0.3 MPa, equivalent to 30 meters underwater for 1 hour, without harmful water ingress).

The waterproof and sweat-resistant features are not permanently effective and may decline with regular wear. These features apply to the headphone body and are suitable for freshwater, tap water, sweat, and pool water. They do not protect against other liquids (e.g., soapy water, cleaners, water with shower gel, shampoo, hot spring water, hot water, seawater). Please clean immediately after contact. ■ Function Descriptions



■ Operating Instructions

A. Power On/Off

Power On: Press and hold the power button for 3 seconds until a startup sound is heard, and the indicator light flashes red and blue alternately. Power Off: When powered on, press and hold the power button for 3 seconds until a shutdown sound is heard, and the indicator light flashes red once before turning off.

B. Wireless Connection

When using the device for the first time, it needs to be paired and connected with a mobile phone or wireless playback device. Follow these steps:


- 1. Power on the headphones by pressing and holding the power button for 3 seconds. The headphones will automatically enter pairing mode, and the indicator light will flash red and blue alternately.
- Open the Settings menu on your smart device and navigate to the wireless connection list. Search for TAKSTAR LR150W and establish a connection, accompanied by a prompt sound if connected successfully.

Note:

- The headphones will automatically reconnect to the previously paired smart device within 3 minutes of powering on.
- If there is no connection after the 3-minute reconnection time, the headphones will automatically power off.

D. Low Battery Reminder & Charging

- 1. Low battery triggers an alert tone charge the headphones promptly.
- 2. Charging: red light on; full charge: blue light.

Note: Align charging contacts correctly for proper polarity – magnetic attraction indicates right connection, repulsion means no charge. Do not force contacts to avoid short circuit.

Note: Use an adapter with 5V output for charging; do not use one over 5V as it may cause damage.



E. Music File Download & Storage

- 1. Use provided cable, connect magnetic end to headphone contacts, USB end to computer.
- Once the computer recognizes the device, a removable disk window will appear. Open your music software to download songs and copy music files (e.g., MP3 format) to the headphone's storage.
- 3. When done, safely eject the disk (by right-clicking the safety eject icon in the bottom right corner of the desktop and left-clicking "Eject removable disk") before disconnecting the cable.

F. Wearing Method



■ Correct Operation

For safe and comfortable operation, please read carefully and abide by the following items:

- 1. To avoid hearing loss, set the volume of the player to minimum before connecting the headset. After putting the earphone on, increase the volume to a proper level. Noise is measured in decibels (dB). Any outside noise of 85 decibels or more will cause gradual hearing loss.
- 2. Please pay attention to your operation habits! Volume and duration are proportional to hearing loss. The higher the volume, the shorter the time you should listen; the more comfortable the volume is, the longer you can listen. Listening at high volume for long will cause damage to your hearing.

This dB level chart compares some common noise sources and their potential danger to your hearing:

Sound Source	Noise Level	Consequence on Hearing	
Whisper	30dB	Very quiet	
Quiet office	50-60dB	Comfortable hearing level is below 60dB	
Vacuum cleaner/ hair dryer	70dB	Somewhat invasive and may interfere with phone calls	
Food processor	85-90dB	85dB (continuously 8 hours) will begin to hurt hearing	
Garbage cleaning machine/ cement mixer	100dB	Exposure to sound of 90~100dB is suggested to be within 15 minutes if without protection	
Electric saw/ electric drill 110dB		Frequent exposure to over 100dB for more than 1 minute can impair hearing	
Rock concert (subjective)	110-140dB	Painful hearing starts at about 120dB	

■ Maintenance
